#### **Full-Time Salaries (Non-Academic Areas)**

Similar to last year, all Non-Academic Areas will have their full-time salaries loaded into Adaptive Planning at 100% of the full-time complement report and no adjustments should be necessary. However, we do suggest you review the Full-Time Salaries Sheet to ensure accuracy. For part-time & temporary salaries, only true part-time salary data is required (i.e. do not include backfill costs for vacant full-time positions).
